This document verifies that Charlotte Bredahl agrees to furnish semen from the Stallion: Windfall CB, Registration #3183002-95, for the 2009 breeding season beginning \_\_\_\_\_ through \_\_\_\_\_. Windfall CB is fully licensed and approved for breeding by the American Hanoverian Society, ISR/Oldenburg N.A., and the North American Division of the Oldenburger Verband.

Subject to the following conditions:

1. The stud fee shall be \$1,700 which includes a non-refundable \$300 booking fee. All fees are due at least one week in advance of breeding. Request for semen must be made at least 24 hours in advance of shipment. Mare Owner acknowledges that Windfall CB is a performance horse which may affect breeding availability. Mare Owner will pay shipping fees and all breeding related veterinarian fees. Mare Owner agrees to use the fresh (or when requested frozen) shipped semen only on the Mare named above. All left-over semen will be destroyed. For the resulting foal, which registry would you like to get papers from? \_\_\_\_\_
2. LIVE FOAL GUARANTEE:
  - A. Mare Owner will have Mare examined by a licensed veterinarian 60 days after last day bred and will notify Charlotte Bredahl of Mare's pregnancy status. Should the MARE ABORT or the FOAL FAIL TO STAND AND NURSE AT 24 HOURS, it is the responsibility of the Mare Owner to notify Charlotte Bredahl in writing by a licensed veterinarian within 10 days of the event.
  - B. Charlotte Bredahl agrees to rebreed the Mare the following year if paragraph 2A holds true, but no more than two (2) seasons. The booking fee is charged each season.
3. If after breeding the Mare through three heat cycles, the Mare fails to conceive, Charlotte Bredahl offers the following options:
  - A. At Charlotte Bredahl's sole discretion, Mare Owner may continue to breed the Mare in the same year or the following season.
  - B. Should the mare die or become unfit for breeding, Charlotte Bredahl may accept a substitute mare.
4. In case Windfall CB dies or becomes unable to reproduce, frozen semen will be available.
5. Mare Owner assumes all responsibility for the condition of the Mare and bear all the risk of loss or damage to the Mare whether by death, disease, injury, infection, accident, sickness or otherwise and by any cause whatsoever, and therefore agrees to hold Charlotte Bredahl, or any person employed or associated with Windfall CB's owner harmless for any and all damages associated therewith.
6. This contract may not be assigned or transferred without the written consent of Charlotte Bredahl.
7. This agreement shall be construed and enforced under the laws of the State of California. Jurisdiction for any arbitration or court proceeding shall be in the County of Santa Barbara, California.
